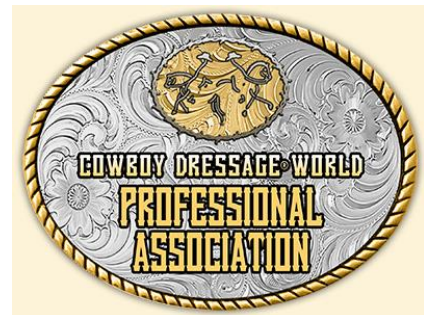
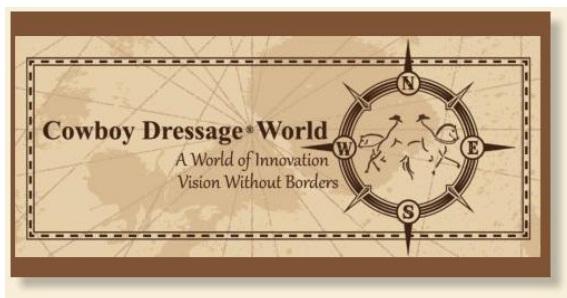

## Competition Requirements

This show will be conducted and judged in accordance with the Cowboy Dressage Rules. The rules can be found at the following site:

It is the competitor's responsibility to read and understand the rules prior to the competition.

All competitors holding a membership with Indiana Cowboy Dressage World Association may compete. Non-members are allowed to compete as well but won't be eligible for year end awards.

A rider may not ride more than 4 riding classes and 4 partnership on the ground classes.

Riders under 18 years old must wear ASTM/SEI approved protective headgear at all times when mounted.

Riders scheduled time will be posted in the Show Office. Any individual ride times are given only as a general guideline, it is the rider's responsibility to keep track of the order of go.

Any changes to the schedule will be posted in the Show Office.

**Dogs:** Dogs are welcome but must be leashed at all times.

**Golf Carts:** Golf carts are only allowed in the non-pedestrian areas, away from the main concourse.

These likenesses will not be used to advertise a product and they will not be used in any way to jeopardize amateur status. ## Prizes and Awards

**Cowboy dressage awards ribbons based on scores:**

**Purple-75% and above**

**Blue- 69%-74%**

**Red-60%-68%**

**White 54%-59%**

**Green 53% and under**

**Awards will be given for the highest soft feel award, highest open rider and highest youth rider and will be presented at the end of the show.**

**Ribbons and score sheets will be available for pick up at the show office shortly after the rider's ride.**
